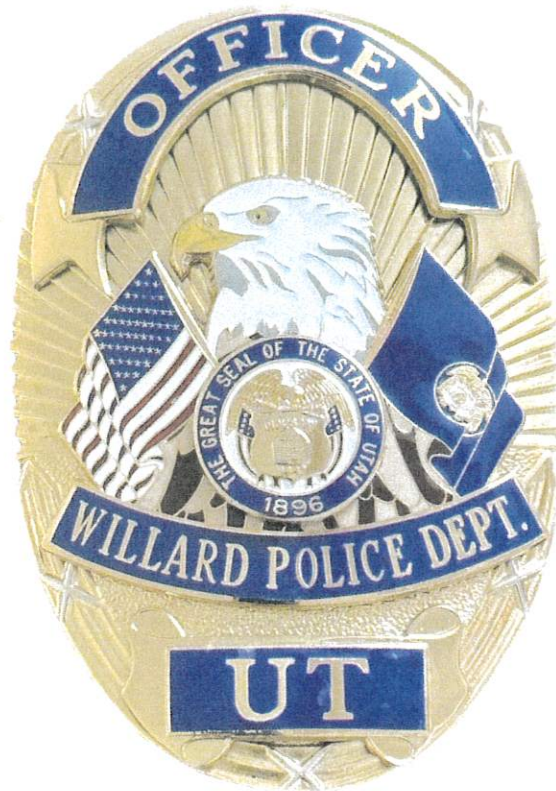

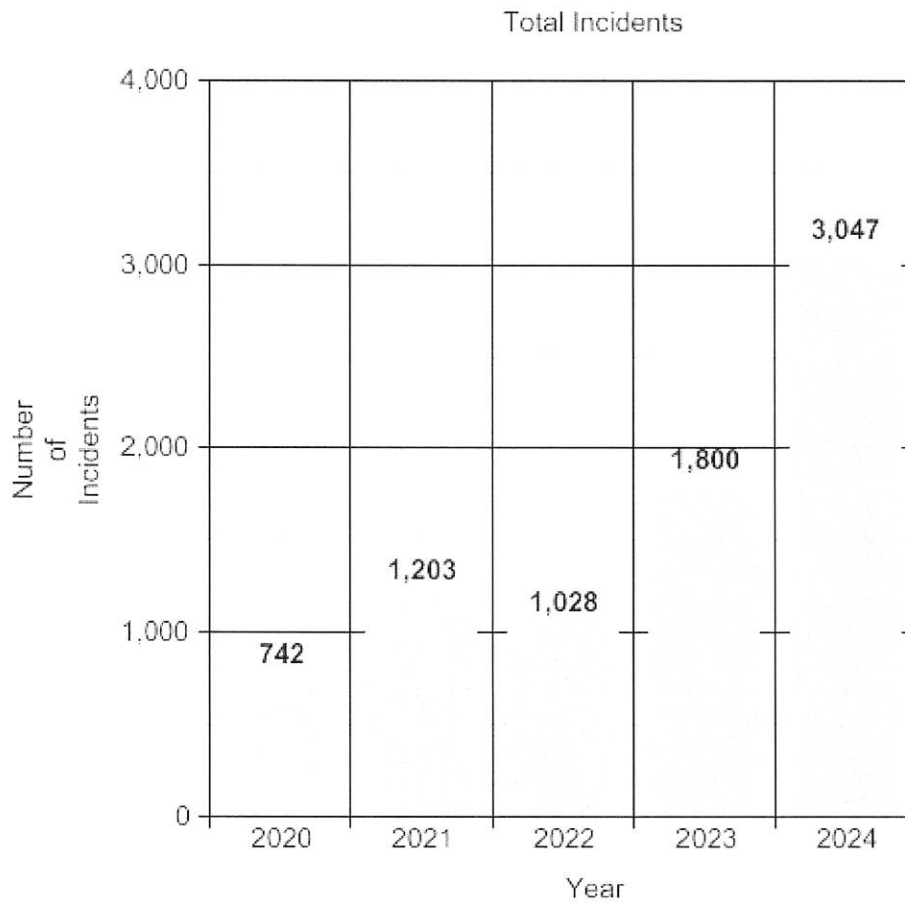

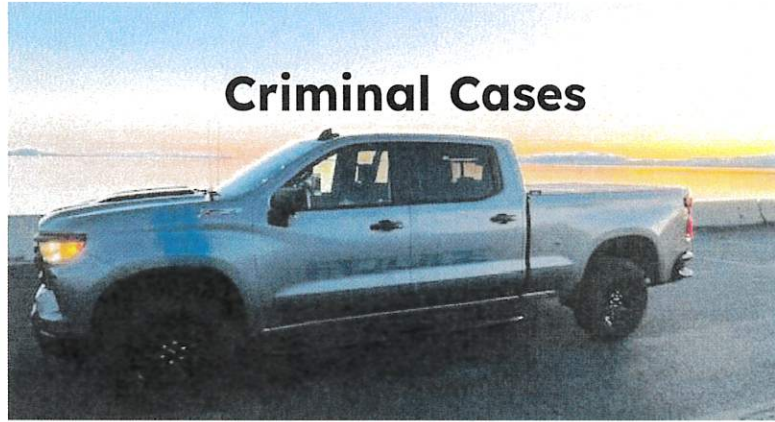

Willard Officers responded to a male in crisis who was intoxicated and had a firearm with him. Willard Officers were able to de-escalate the situation and help the male in crisis.

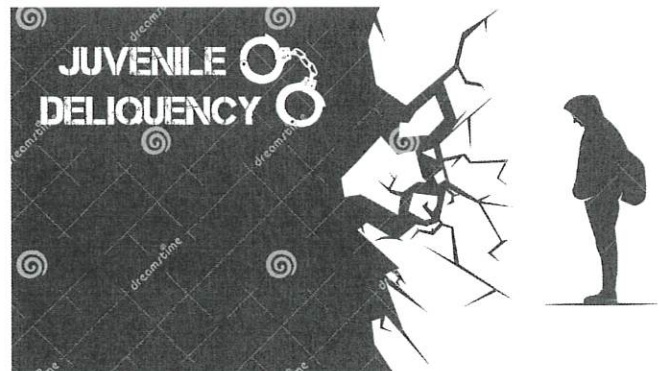
Willard Officers responded to a female in crisis who had a knife. Willard Officers were able to de-escalate the situation, and the female was taken to the hospital.

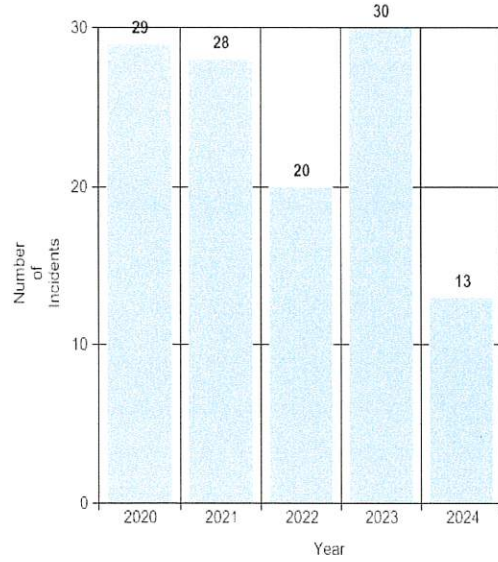
Members of the Willard City Police and Fire Departments, as well as Box Elder Communications Center were recognized for their actions for two drownings at Willard Bay.



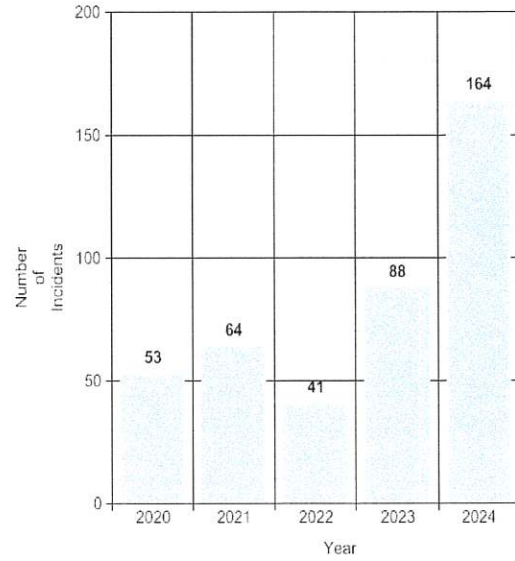


Year by Nature Stats

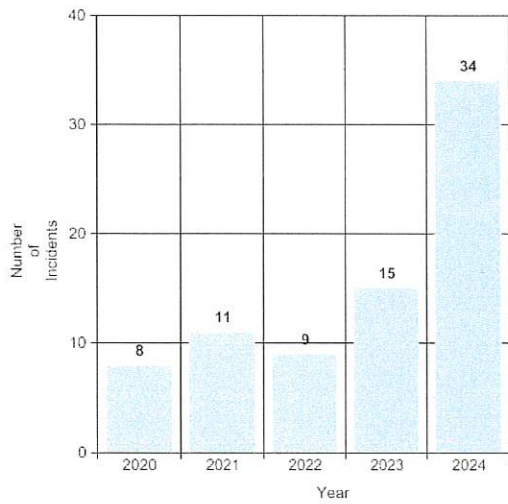

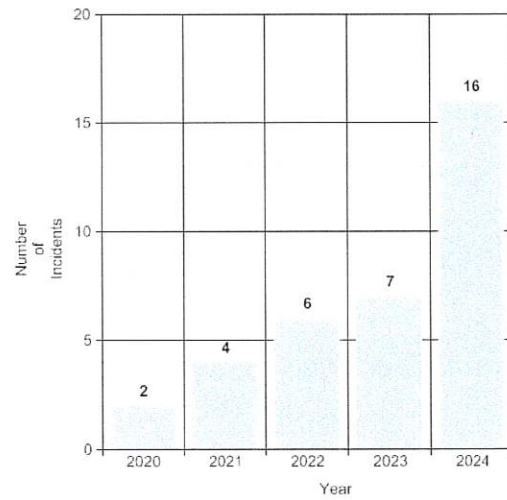

Drug and DUI Cases

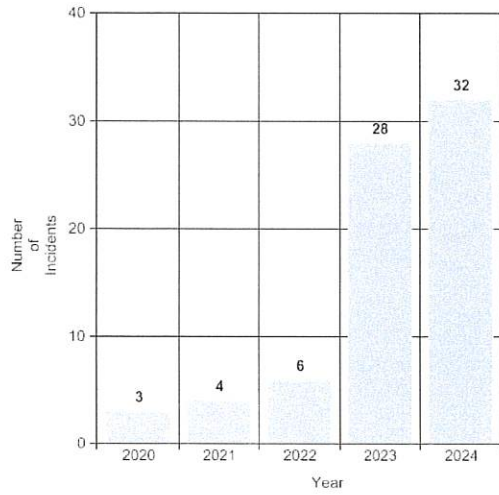
